Sealed Bids for Village of Swanton, Ohio; Project 7; Church, Harrison, Lawrence Sewer Separation, will be received by the Village of Swanton, Ohio, at the office of the Village Administrator, 219 Chestnut Street, Swanton, Ohio 43558, until 3:00 p.m., local time, on May 2, 2018, at which time they will be publicly opened and read.

In general, the work consists of 6,300 lineal feet of storm and sanitary sewer installation, the reconstruction of Church Street including new curbs and milling, and asphalt overlay on Harrison, Lawrence, and East Garfield.

Bids must be submitted on the forms bound herein, must contain the names of every person or company interested therein, and shall be accompanied by either a Bid Guaranty and Contract Bond in the amount of 100% of the amount bid with satisfactory corporate surety, or by a certified check on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. The successful bidder will be required to furnish satisfactory Performance Bond and Maintenance and Guarantee Bond in the amount of 100% of the Bid.

The Contractor shall be required to pay not less than the prevailing Davis-Bacon Wage Rates established by the Ohio Bureau of Employment Services, Wage and Hour Division.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 60 days after the actual opening thereof.

Domestic steel requirements, as specified in the American Iron and Steel (AIS) requirements, a copy of the requirements are included in the Specifications.

This project is subject to EPA Policy of Encouraging the Participation of Small Business Rural Access (SBRA) and Disadvantaged Business Enterprises (DBE) Utilization.

Completed WPCLF and OWPC forms must be included with Bids.

The successful Bidder will be required to complete the “Declaration Regarding Material Assistance / Non-Assistance to a Terrorist Organization (DMA) in accordance with ORC Sections 2909.32 and 2909.33.

The Owner reserves the right to reject any or all Bids, waive irregularities in any Bid, and to accept any Bid which is deemed most favorable to the Owner.
