## 1. Inspection on projects

At the last Public Service Committee meeting, there was discussion on inspection services. Administrator surveyed other communities for their fee structure and presented it. Administrator recommends stating there is a fee, and stating to refer to fee structure.

#### 2. Memorial Park Fence

# 1. Operation of low speed vehicles

## 1. 2018 Appropriation Review

Discussed why total appropriations are so high. The Grant Funds for the Garfield Bridge must be listed as revenue coming in and expenditures going out.

Memorial Park Pavilion project is contingent on grant funding but total amount is needed to appropriate. Received word on 9/12/17 that not all CDBG grant funding was approved. The state is approving \$16,000 towards this project. Should receive word from ODNR on the Natureworks grant by end of October. Discussion will be need if Natureworks is not successfully received, does Committee wish to pursue any other local funding.

The Fire Fund proposed appropriations illustrate an increase across the board, due to increase in wages.

Administrator sent information to Fulton County Auditor Brett Kolb to assist with producing a spreadsheet of breakdown costs using the approved mechanism to calculate contract fees for the Townships.

#### 2. Lot 61- West Point Estates

Vacant lot in West Point Estates west of Carriage, south of Promenade. Village owns and maintains. Many complaints of dumping. Council would like to get property surveyed and then have further discussion on it.

#### 3. Paper Alleys

Map of alleys within the Village was given and discussion on what can be done with them.
