Fulton County. She judged the 4 way Test for Rotary at Swanton High School. Finally she attended the CIC annual meeting in Wauseon.

- 1. Construction Open House
 - a. March 28 in Swanton Community Center 6:30-7:30 p.m.
- 2. OPWC Round 33 Application Discussion
 - a. As the 2018 construction season begins it is already time to think about the 2019 and 2020 construction season and which, if any, project to submit through OPWC Round 33
 - b. In Round 32 the Village submitted an application related to the alley between Main and Lincoln as well as the alley north of Dodge
 - i. This project did not get funded
 - ii. Can resubmit if interested
 - c. Other recommended projects, utilizing the road inventory done in 2017
 - i. West Point Estates
 - This option could also include Lee High if Council would like to partner with Swancreek Township to improve the road
 - 2. There are three properties on Lee High within the incorporated limits and the Village owns one parcel on the road

- 1. Garfield Avenue Bridge Replacement Bid
 - a. The bid opening for the project was March 16 at 2:00 p.m.
 - b. Only one bid was submitted
 - i. Miller Bros
 - ii. \$846,581.85
 - c. DGL Consulting Engineers have reviewed the bid document and have no issues
 - d. Committee recommends approval

2. Christmas Decorations

- a. Christmas seems far in the distance but planning and organizing for decorating the Village will begin before we all know it.
- There are many Christmas decorations which are in need of replacement or disposal
 - i. There are some decorations which are becoming costly to maintain as the light bulbs burn out or break frequently during one season
- c. Further, Pilliod Park is in dire need of an electrical audit to ensure safety
- d. As the Christmas decorations are a mainstay in the Village, the Administrator is recommending creating a Committee of members from the Community to discuss Christmas decorations in the future
- e. Committee recommends creation of a committee. Councilman Rochelle indicated he would like to be a part of it
- 3. High School Athletic Fields and Memorial Park Ball Diamond water rate structure
 - a. There are three (3) accounts for Swanton High School Athletic Fields
 - i. Football Field (labeled "Main Field" in the utility system
 - ii. 2 for the Practice Field (labeled "Soccer Field" in the utility system)

- b. Ordinance 2015-7 set forth a discounted water rate structure for the Athletic Fields at Swanton High School
 - i. "shall be charged \$3.00 per thousand gallons or a minimum charge of \$3.00 per month."
- c. Discussion
 - Councilman Rochelle stated that if the School would like to do all the improvements they can go ahead and do that and the Village will pay for the water at Memorial Park
 - ii. Mr. Pilliod inquired about the High School and what exactly is charge. Looking for what it cost to produce 1000 gallons of water

4. Jet Vac Truck Update

- a. Mr. Tedrow and the Administrator met with reps from Best Equipment to review details about a jet vac truck
- b. Best Equipment sells Vac-Con brand trucks
 - i. Creator of Vac-Con used to work at Vactor but left to start his own business
- c. Still waiting for Jack Doheny quotes
- d. Swancreek Township indicated they would offer the use of their equipment if needed

ALS 7- Chief Wolever announced the new unit was delivered on March 22. It will not be in service for over a month as it must be equipped with certain items. Chief Wolever believes there should be a dash camera but it was not part of the specs.

Chief Wolever also reports the abnormal amount of brush fires in the past couple weeks. Increase in open burning the last couple weeks lead to this.

- 1. Review of Rules of Council
 - a. It has been almost 2 years since Rules of Council were last updated
 - i. It is beneficially to review periodically to amend where needed
 - b. Currently Rules are located in Dropbox
 - c. Some issues which are not addressed or can be elaborated on
 - i. Emergency and/or Special meeting public comments
 - ii. Open Public Comments at the end of meetings
 - d. Discussion of public comments
 - i. Limit to certain time
 - ii. Limit to a certain number per topic
 - iii. Discretionary by the power of the Mayor?\

It was decided that the Administrator would review other communities Rules of Council.

Councilman Dzyak had some suggestions: review pronouns, remove authorizing bills, and change Clerk to Fiscal Officer.

- 2. Nuisance Section 92 Codified Ordinances
 - a. For the past 6 months the Administrator and Mr. Brown have worked with legal counsel on updating Section 92 of the Codified Ordinances
 - b. Two main sections were overhauled
 - i. Definitions
 - 1. Clarified many vague sections
 - ii. Abatement procedure
 - Revamped the procedure to allow the Administrator, or his/her designee, the ability to pursue abatement without having to present before Council
 - The only time the abatement would be presented to Council is if the Village had to abate and Village Council needed to levy assessments to the property
 - c. The proposed revisions are in Dropbox
 - d. Committee recommended first reading legislation for next meeting
