REQUESTING COUNTY AUDITOR TO PROVIDE REQUIRED TAX LEVY INFORMATION, AND DECLARING AN EMERGENCY

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Village of Swanton, Fulton County, Ohio, and it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Swanton for the purpose of the construction and acquisition of specific permanent improvements for Village park, at a rate not exceeding fifty hundredths (0.50) mills for each one dollar of valuation, which is a renewal of an existing 0.5 mill levy;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Swanton, Ohio, two-thirds (2/3) of the members elected thereto concurring and as follows:

Section One: That it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Swanton:

- (a) for the purpose of the construction and acquisition of specific permanent improvements for Village park;
 - (b) for a period of 5 years;
 - (c) which tax will be a renewal of an existing 0.5 mill levy;
- (d) which tax is to be levied upon the entire territory of the Village of Swanton and shall be submitted to the entire territory of the Village of Swanton. The Village of Swanton has territory in Fulton County and Lucas County Ohio;
- (e)which tax shall be placed upon the tax list commencing Tax Year 2019, first due in calendar year 2020, if a MAJORITY of electors of the Village of Swanton vote in favor thereof at the election to be held May 8, 2019, and
 - (f) which levy is authorized by O.R.C. Sections 5705.19(H), .191, 192, .26; and be it further

Section Two: that pursuant to O.R.C. Section 5705.03, the Fulton County Auditor is hereby requested forthwith to determine and certify to the Village of Swanton the total current tax valuation of this subdivision and the dollar amount of revenue that would be generated by a fifty hundredths (0.50) mills tax levy; and be it further

Section Three: that the Village of Swanton Fiscal Officer be and hereby is directed to certify a copy of this Resolution to the Fulton County Auditor; and be it further

Section Four: that upon receiving the certification from the Fulton County Auditor, the Council of the Village of Swanton will determine whether to proceed with the submission of the question of the tax to the electors.

Section Five: That it is found and determined that all formal actions of this Village Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Village Council, and that all deliberations of this Village Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section Six: That this Resolution shall be declared an emergency measure necessary for the immediate preservation of public health, safety and welfare of the Village of Swanton; wherefore this resolution shall be in full force and effective immediately upon passage.
