If you continue to question the authenticity of the letter or form call the Regional Office for your state to verify the household survey.

If someone visits your residence to complete a survey: check first for a valid U.S. Census Bureau ID badge. if you are still unsure then call the <u>Regional Office</u> for your state to verify you are in a legitimate survey and the visitor is a Census Bureau employee

If you get an e-mail and think it is bogus: do not reply, do not click on any links, and do not open any attachments, forward the e-mail or website URL to the Census Bureau at ois.fraud.reporting@census.gov
