

Ordinance 2020-20

AN ORDINANCE AMENDING ORDINANCE 2020-17, WHICH AMENDED ORDINANCE 2020-07, 2020 PERMANENT APPROPRIATION ORDINANCE, AND DECLARING AN EMERGENCY

BE IT ORDAINED, by the Council of the Village of Swanton, two-thirds (2/3) of the members elected thereto concurring and as follows:

Section One. That Ordinance 2020-07, including amendments in Ordinance 2020-17, 2020 Permanent Appropriation Ordinance, be amended to increase appropriations in the newly created Coronavirus Relief Fund, as a result of more funds received as well as amendments to increase appropriations in Funds 2041, 5781, 4902, and 1000 for expending monies during the 2020 appropriated year, as follows:

Fund	Appropriation	Adjustment	Amended Appropriation
2052 Coronavirus Relief Fund	\$81,955.43	+ \$180,004	\$ 261,959.43
5781 Renter Deposit	\$8,000	+\$4,000	\$12,000
4902 Fire Capital	\$15,000	+\$575,000	\$590,000
1000 General	\$1,731,000	+\$200,000	\$1,931,000

Section Two: That revenues be amended in 2041, 2052, 4902 as follows:

Fund	Revenue Adjustment
2052 Coronavirus Relief Fund	+\$ 180,004
2041 Park	+\$25,000
4902 Fire Capital	+\$280,000

Section Three. That it is found and determined that all formal actions of this Village Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Village Council, and that all deliberations of this Village Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section Four. That this ordinance shall be declared an emergency measure necessary for the immediate preservation of public health, safety and welfare of the Village of Swanton; and for the further reason of the need to increase the appropriations for the remainder of the year to provide municipal services, wherefore this ordinance shall be in full force and effective immediately upon passage.


