

## Resolution 2021-12

### A RESOLUTION AUTHORIZING THE VILLAGE OF SWANTON TO PARTICIPATE IN OMNIA PARTNERS, PUBLIC SECTOR COOPERATIVE PURCHASING PROGRAM AND DECLARING AN EMERGENCY

WHEREAS, ORC Section 9.48 (B)(2) allows municipal corporations as political subdivisions to participate in joint purchasing programs operated by or through national or state associations of political subdivisions; and

WHEREAS, OMNIA Partners is the largest and most trusted cooperative purchasing organization for public sector procurement. They brought together two leading cooperative purchasing organizations - National IPA and U.S. Communities - under one roof to form OMNIA Partners, Public Sector;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF SWANTON, STATE OF OHIO:

Section 1. That Village Council authorizes participation in national cooperative purchasing contracts which OMNIA Partners, Public Sector has entered into for the purchase of supplies, services, equipment, and certain other materials pursuant to the Ohio Revised Code Section 9.48 (B)(2) by executing a OMNIA Partners, Public Sector Agreement and/or Participating Membership Agreement

Section 2. That the Village Administrator, and/or their designee, is hereby authorized to agree in the name of the Village of Swanton to be bound by all contract terms and conditions as OMNIA Partners, Public Sector prescribes. Membership is free and there is no obligation to purchase through these contracts as a member.

Section 3. That the Village Administrator, and/or their designee, is hereby authorized to agree in the name of the Village of Swanton to directly pay the vendor, under each OMNIA Partners, Public Sector contract, in which it participates for items it receives pursuant to the contract, and the Village Administrator, and/or their designee does hereby agree to directly pay the vendor.

Section 4. That it is found and determined that all formal actions of this Village Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Village Council, and

that all deliberations of this Village Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 5. That this resolution is hereby declared to be an emergency measure necessary for the preservation of the village peace, health and safety; wherefore this resolution shall be in full force and effective immediately upon passage.


