Councilman Kania moved to approve agenda as amended to include a Hydrant Use Permit. Seconded by Councilwoman Disbrow. No Discussion. Roll Call. ALL YES. Motion passed 5-0.

Councilman Kania moved to approve the hiring of Randall Trausch as a part-time member of the Fire and Rescue Division, effective June 6, 2022 at an hourly rate of \$15.20/hour contingent on successful completion of drug screen and background check. Mr. Trausch is subject to a 6-month introductory period effective June 6, 2022. Hire is also contingent on Mr. Trausch agreeing to work a minimum of 24 hours per month. Seconded by Councilwoman Westhoven. No Discussion. Roll Call. ALL YES. Motion Passed 5-0.

acquire booms from the Swanton Fire and Rescue Department to ensure minimal debris enters the Sanitary Sewer system. Roll Call. ALL YES. Motion Passed 5-0.
