Councilman Kania moved to approve agenda as Amended to include Committee Reports. Seconded by Councilman Messenger. No Discussion. Roll Call. ALL YES. Motion Passed 5-0.

Councilman Messenger moved to approve minutes from October 11, 2022. Seconded by Councilman Kania. No Discussion. Roll call. ALL YES. Motion Passed 5-0.

### Public Comment

- G. Waterstadt of 206 E. St. Clair St. stated that SACC can support the new boundaries. Was concerned regarding the timeframe, given that Maumee starts their DORA time at 4pm. Also mentioned that Napoleon and Perrysburg are different than what the Village is proposing. Suggested a timeframe of 4-5 pm for starting the DORA period during the week.
- J. Benfield, owner of Benfield Wines (102 N. Main St) noted that the law regarding DORA was changed 3/23/22, to modify the number of licenses required. Wanted to see earlier timeframes allowed in order to have events downtown. Would like to see longer times on the weekends. Requested that the Mayor or Solicitor offer education regarding liability issues from anything that should arise within the DORA.
- R. Kazmierczak of 6739 County Road 3, also Swan Creek Township Trustee, noted that the Trustees had worked with the previous members of Council over the last 6 years to reduce dual taxation regarding fire coverage. Stated that no government official wanted to see double taxation. Mentioned a shorter length to future contracts was not advisable, that fewer levies is better for all residents, and that an escalator clause should be considered for future fire contracts. Noted that York Township does offer a bi-annual raise in rates. Providence Township did freeze rates, but they get paid per run into the Township. He believes rates are going up as they should.

- D. Schmidt of 106 N. Main St. (Level Fitness) stated that a lot of businesses wanted to see the DORA enacted. Stated that she has been to several DORA areas and believes that this will bring people to the area. 2016 2018, she voiced concerns to Council and the Mayor about the number of trains and their speed. Noted there was no more room for liquor licenses, but that there are plenty of available storefronts.
- R. Howard of 607 E. Garfield mentioned he is a 10-year resident of the Village. Loves town but feels that the Village lacks a center of life. Thinks DORA will help enhance it, and believes it to be a good opportunity for the Village of Swanton.
- B. O'Connell of 2121 County Road EF, whose family owns the Swanton Sports Center, believes DORA is a good idea. Noted that economic development brings people to town and could increase tax base. Believes that we are being innovative.
- E. Butler of 111 Black Canyon Drive, is outraged at these thoughts and distractions from what DORA will provide. Spoke with Patrick Leahy and his father, who formed the first DORA in Toledo the Adams St. area. Noted that the arguments now are the same as then, but that Adams St has been revived. Remembers when downtown Swanton was vibrant, and is now concerned about abandoned buildings. Does not think that alcohol outside will bring crime. Recalled "bogeyman" regarding the train yard, and noted that we need progress to grow some businesses are not retail and would not benefit, but those that are and would can use this to grow.
