# RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION, AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR AND DECLARING AN EMERGENCY

WHEREAS, The Budget Commission of Fulton and Lucas County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within, the ten mill limitation;

NOW THEREFORE BE IT RESOLVED, By the Council of the Village of Swanton, Fulton and Lucas County, Ohio, two-thirds (2/3) of the members elected thereto concurring and as follows:

Section One: That the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.

Section Two: That there be and is hereby levied on the tax duplicate of Fulton and Lucas County the rate of each tax necessary to be levied within and without the ten mill limitation as follows:
