Resolution 2024-17

A RESOLUTION AUTHORIZING THE SUBMISSION AND SUPPORT OF AN APPLICATION TO THE OHIO BUREAU OF WORKERS' COMPENSATION FIREFIGHTER EXPOSURE TO ENVIRONMENTAL ELEMENTS GRANT (FEEG) PROGRAM AND DECLARING AN EMERGENCY

WHEREAS, the <u>Ohio Bureau of Workers' Compensation</u> administers the <u>Firefighter Exposure to Environmental Elements Grant (FEEG)</u> Program; and

WHEREAS, the Village of Swanton desires to seek funding assistance through the <u>Firefighter Exposure to Environmental Elements Grant (FEEG) Program</u> for <u>Personal Protective</u> Equipment used by Swanton Fire and Rescue at the Village of Swanton, Fulton County, Ohio.

NOW THEREFORE BE IT RESOLVED, by the Council of the Village of Swanton, Fulton County, Ohio, three-fourths of the members elected thereto concurring and as follows:

Section One. That the Council of the Village of Swanton approves filing an application for financial grant assistance through the <u>Firefighter Exposure to Environmental Elements Grant</u>

(FEEG) Program and, if funded, entering into the required grant Agreements.

Section Two. The <u>Fire Chief</u> is hereby authorized and directed to execute and file an application with the <u>Ohio Bureau of Workers' Compensation</u> and to provide all information and documentation required to become eligible for funding assistance to execute any and all other documents necessary to effectuate this designation.

Section Three. That this Council agrees to obligate the funds required to apply for the project and to satisfactorily complete the project if the cost is in excess of the award amount.

Section Four. That it is found and determined that all formal actions of this Village Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Village Council, and that all deliberations of this Village Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section Five: That this resolution is hereby declared to be an emergency measure necessary for the preservation of the village peace, health and safety; wherefore this resolution shall be in full force and effective immediately upon passage.
